REQUIRED DOCUMENTS	
☐ Homeowners insurance designating Lexington Postal Community Credit Union as the "loss payee" must be brought to closing.	
☐ First mortgage loan application for primary borrower filled out and signed.	
☐ If there is a co-borrower, first mortgage loan application for additional borrower filled out and signed.	
☐ HUD booklet available for download on lexpccu.com and provided upon receipt of application.	
□ Verification of deposit form if 20% deposit is coming from somewhere other than LPCCU account.	
☐ Member to provide last two years of W-2's and last 30 days of pay stubs.	
☐ Tax returns from the past two years with forms attached if self-employed or retired.	
☐ Annual retirement statement and/or social security benefits statement if retired.	
☐ Purchase contract if you are purchasing a home.
